RoHS Compliance Declaration* (May 2019)

We, Memphis Electronic AG, hereby certify that **our products** containing RoHS in the parts description are in compliance with the European directive 2011/65/EU** and 2015/863/EU*** Restriction of the use of certain Hazardous Substances (RoHS) in electrical and electronic equipment (EEE) – recast and its amendments of the European parliament and of the council (RoHS 3).

The RoHS-conformity of the **distributed** electronic products / electronic components can be usually derived from the the device's part number, description and the manufacturer's data sheet.

The substances concerned are listed in Annex II of 2011/65/EU. The first version was released on 1st of July, 2011 and amending Annex II to RoHS Directive 2015/863/EU was released on 31st of March, 2015 in the Official Journal of the European Union.

The substances and their respective limits are as follows:

6	Polybrominated diphenyl ethers (PBDEs)	< 0.1% (1000 ppm)
7	Bis(2-ethylhexyl) phthalate (DEHP)	< 0.1% (1000 ppm)
8	Butyl benzyl phthalate (BBP)	< 0.1% (1000 ppm)
9	Dibutyl phthalate (DBP)	< 0.1% (1000 ppm)
10	Diisobutyl phthalate (DIBP)	< 0.1% (1000 ppm)

We claim for the following exemption according to 2011/65/EU Annex III may apply to our product:

7(c)-I Electrical and electronic components containing lead in a glass or ceramic other than dielectric ceramic in capacitors, e.g. piezoelectronic devices, or in a glass or ceramic matrix compound.

We claim for the following exemption according to 2011/534/EU Annex (a) may apply to our product:

7(c)-IV Lead in PZT based dielectric ceramic materials for capacitors being part of integrated circuits or discrete semiconductors
